(y) To transfer and hand over the Trust to any other Society, Corporation, Institution, Trust or Organization on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the Society, Corporation, Institution, Trust or Organization with the powers, provisions, agreements and declarations, appearing and contained in these presents subject to such modifications as may be necessary and consequent to such transfer of the Trust fund. The Trustees for the time being of these presents shall become discharged from the Trust thereof relating to Trust Funds so transferred.

8. The Trustees shall be accountable only for such moneys, stocks, shares and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, default, acts or omissions or commissions of the other trustees, nor of any banker or other person with whom the trust properties or any securities may have been deposited or kept.

9. The Trustees will not be entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.



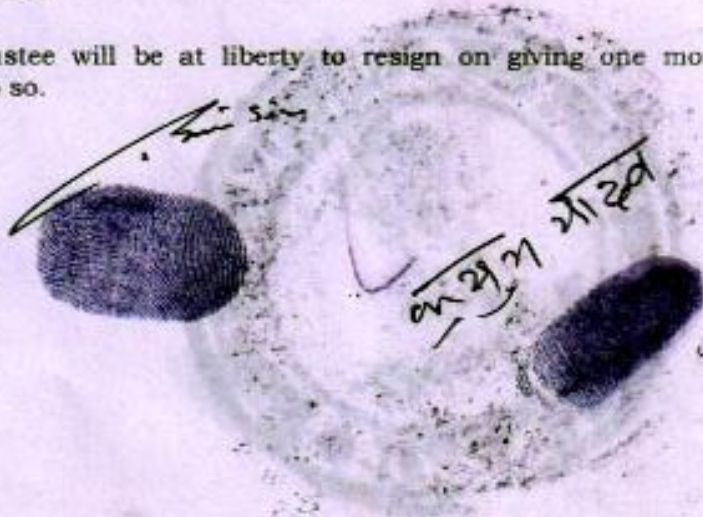
10. The number of the Trustees shall not be less than two and more than seven. If the number of the trustees shall fall below two, the Trustees shall not, except for the purposes of filling any vacancy, act so long number is below the said minimum.

11. The Board of Trustees shall elect the following office bearers from amongst themselves:

- Chairman Cum Treasurer
- Hony Secretary

12. The managing trustees for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on -such terms as to retirement and re-appointment as the trustees for the time being considered proper. A person shall cease to be a Trustee either: (i) if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, whichever is longer, or (ii) if he is requested to resign by 3/4th or as near thereto as possible of the remaining trustees

13. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.



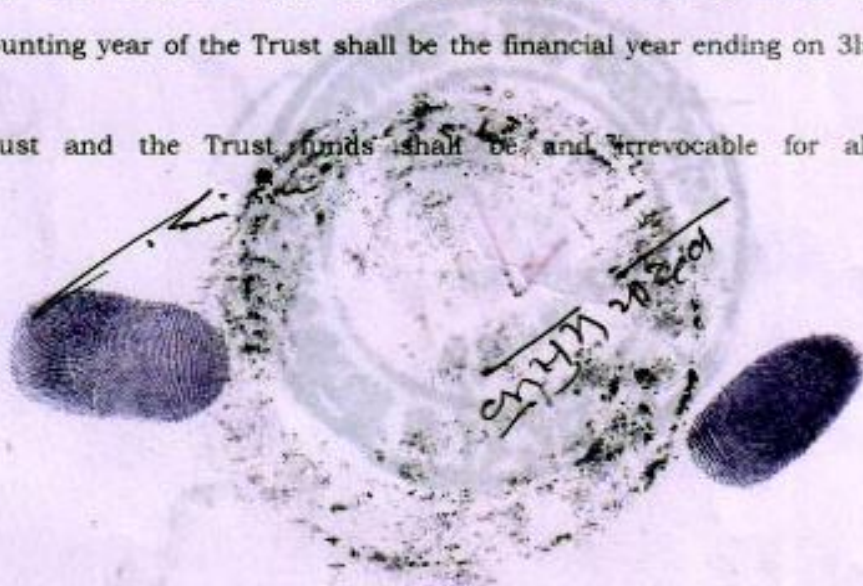
14. The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:-

- (a) **Two Trustees shall form a quorum for a meeting of the Trustees.**
- (b) All matters will be decided mutually by the Trustees.
- (c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.

15. The Trustees shall have the power to determine in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoings ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorise the Trustees to spend the income or corpus of the Trust for any purpose not authorised by these presents.

16. The accounting year of the Trust shall be the financial year ending on 31st March every year.

17. The Trust and the Trust funds shall be and irrevocable for all times.



18. The office of the Trust shall be situated at Bareilly in Uttar Pradesh unless changed by the Trustees by two thirds majority.

19. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any Purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.


- That notwithstanding anything hereinbefore or hereinafter contained the income as also the corpus of the said Trust Fund shall be applied and/or be applicable to or for such public charitable purposes and objects and within such territories only and subject to such conditions or limitations if any, as may from time to time be laid down in the Income Tax Act 1961, or any replacement or re-enactment thereof or modification or substitution thereof or any other act governing taxation for the time be in force in India.
- That the said Trust shall be one to which the applicable provisions of the Income Tax Act, 1961 or any replacement or re-enactment or modification thereof for the time being in force shall so apply so that any donation thereto be recognized eligible for exemption or relief from tax in regard to the donor as far as possible.

- That every contribution by the Trustees to any other registered Public Trust, Society or Institution, Fund or scheme having as its sole objects all or any of the aforesaid public charitable objects shall be treated and deemed to be furtherance and achievement of the objects of the said Trust.
- That notwithstanding anything contained hereinabove the Trustees shall be at liberty to delete, modify or alter or add to any of the objects or provisions hereof which are found contrary or inconsistent with the concept of public charitable purposes or objects or outside the scope of the Income Tax Act, 1961, or any re-enactment, replacement or modification or substitution thereof and/or other taxation laws as may be applicable from time to time and enforced in India or the provisions of any other law relating to Charitable Trusts in India.

21. The board of Trustees may borrow from any Trustee of these presents and from Banks, Financial Institution and from any other source such sum or sums of money as they may think necessary for the purposes of the Trust hereby created.

22 **Management of the Trust:** The Chairman shall preside over all the meetings of the Board of Trustees. The business of trust shall be conducted under his directions and guidance. Sh Rajesh Yadav be the first Chairman of this Trust and shall remain become the Chairman till his life time, until he himself not resigns from the said post. In the event of any vacancy arising on account of resignation or any other cause, of any office

bearer, the board of Trustees shall elect the new office bearer in this place from amongst themselves. Sh Rajesh Yadav, being as a first chairman of the trust is having the rights to select a Management Committee to run the said trust. He is having to right to appoint or rusticate any person from the said Management Committee without given any reason. All the decision taking by Management Committee must be approved by the First Chairman Sh Rajesh Yadav and after his consent the said decision shall be formed. The Hony Secretary shall issue notices for all meetings of the Board of Trustees, in consultations with the directions of the chairman. However, the chairman of the Trust is authorize to issue notice regarding any matter. He /She shall maintain records and minutes of the proceedings of the meetings. He shall co ordinate the activities of various committees.

23 Let Out Property: The Board of Trustees may let / lease out any movable/ immovable property of the Trust in their absolute discretion in such manner as the Trustees may think proper.

24 Hold Property of Trust: All properties that may be acquired by the Trust shall be held by the Board of Trustees in Trust, and the same together with income there from, if any, shall always by utilized for the purposes and objects of the Trust. It shall, however, be lawful for the Trustees to accumulate the income of the Trust for utilization at a later stage.

25 Open of Bank Account: The Trustees shall have the power to open and operate Account/ Accounts for purposes of the Trust with any one or more scheduled Banks or with any Financial Institution as may be decided by them.

26 Reimburse Expenses: The Trustees may themselves out of the Trust funds all expenses legitimately incurred by them in the execution of and for the purposes of the Trust.

27 Property to be administered as per Provisions: The Trust's assets shall be administered, controlled, spent and managed in accordance with the provisions contained in these presents and Rules and Regulations in vogue.

28 Manage Prudently: The Trustees shall manage the subject matter of the Trust Prudently and in such manner as they would do in case of their own affairs.

29 Chairman of the committee: A trustees alone shall be entitled to become the Chairman of such Committees/ Sub Committees.

30 Ex Office Members of the Committee: The Chairman of the Trust shall be ex-office member of all such Committees/ Sub- Committees.
