

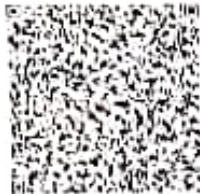

**AFFIDAVIT**

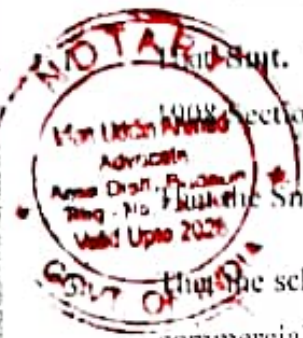
